The security deposit for use of the pavilions is \$100.00, for use of the barns and/or horse rings is \$100.00, and for use of the bathrooms is \$100. The Lessee acknowledges and agrees that, should there be any damage to the facilities, buildings, grounds, personal property, equipment, or the like, the Lessee will be solely responsible and payment shall first be deducted from the security deposit with the balance (if any) due to the Lessor. Security deposits can be rolled over to the next rental.

By signing this agreement, the Lessee acknowledges that it has read the same and the Rental Rules and Regulations and fully agrees to comply with its terms and conditions as set out herein. **No contract is complete until signed by the Lessor and a copy of such signed agreement is sent to the Lessee as confirmation.** The original agreement will be retained by the Lorain County Fair Board Office.

Any other request that includes participants outside of current 4-H members is a paid rental that should be contracted through the fair office. This includes any shows/activities that are open to adults, youth from outside organizations, etc.**
